- Do not put "see attached" on the form and then expect the committee to pull the high points from pages of documentation. Do not attach a long list of vitae that includes nonhelpful information such as nights camped, meetings attended, miles hiked, etc.
- Service as a unit leader is strongly recommended.
- Rarely are persons with less than ten years of adult tenure considered.
- Professionals are not allowed to nominate someone, nor provide letters of recommendation.

### Letters of Recommendation

- Although not required, a quality nomination will have attached a few letters of recommendation.
- A quality letter of recommendation will bring to light service and qualities that may not be on the nomination form.
- Letters of recommendation that simply repeat what is on the nomination form are not helpful.
- Form letters are non-productive.
- Look for quality sources for letters of recommendation from employers, pastors, civic leaders, Scouts directly affected by the nominee, etc.
- Nominations or letters from spouses are not desired.
